Introduction

Data Analysis Plan

Data Entry:

All survey responses will be entered into a secure database. For paper surveys, data will be manually entered by trained staff. Online survey data will be automatically captured.

Data Cleaning:

Responses will be reviewed for completeness and accuracy. Any inconsistent or unclear responses will be flagged for follow-up or omitted from analysis.

Quantitative Analysis:

Descriptive statistics will be used to summarize demographic information and the prevalence of each social issue. Cross-tabulations will be conducted to explore how social issues vary by demographic groups (e.g., age, gender, length of residency in the USA).

Qualitative Analysis:

Open-ended responses will be coded for common themes. This qualitative data will provide deeper insights into the specific challenges and needs of the Haitian community.

Reporting:

Findings will be compiled into a comprehensive report. This report will include:

1. An executive summary highlighting key findings.
2. Detailed analysis of each section of the survey.
3. Recommendations for addressing identified social issues.
4. Quotes and narratives from participants to illustrate key points.
